Comments: **Tenisha and Gregory are the parents of Bilal (13). Tenisha resides outside of the home.**

Three years ago, Tenisha strangled Bilal which resulted in him being placed with Gregory and Tenisha only given seven hours a week of supervised visit. Recently, the court granted Tenisha partially custody, so Bilal will be going with her tomorrow. There are concerns for Bilal mental state due to being in the care of his strangler. Also, Bilal was diagnosed with anxiety due to being strangled by Tenisha over the years. No further details provided.
